a. The board discussed the following mid-year budgets.

A motion was made to approve the Gilmore Center budget \$113,513 which is \$71,581 county portion and \$41,932 city portion and Pine Mountain Library \$186,638 which is \$118,664 county portion and \$67,974 city portion. The increase for the library is mostly due to the increase in the Teacher’s Retirement. This approval is contingent on the City of Thomaston’s approval.

They are requesting a \$10,000 increase for three law clerks, a supplement is included for a Senior Judge for \$24,000 which was not included the previous year and there is an increase in the case load for Superior Court and Juvenile Court. There was no action taken on this item.
