Generally, as to hearing dates, please alert the judge's chambers if you expect a particular hearing to take over 1 hour.

Please also observe and comply with Uniform Superior Court Rule 17.1, requiring notice of any conflict at least 7 days in advance. Faxed conflict notices the night before a hearing fail to comply with USCR 17.1, which is to allow judges, not counsel, to control the sequence of counsel's appearances in courts. Thank you for your respectful observation of USCR 17.1.
