The REZ2023-02 applicant and property owner, George L. Crook of Thomaston, Georgia, has requested that Upson County rezone twelve existing (12) lots, to be combined into a single lot, on Banks Street and Sherman Drive from R-5 to A-R for agricultural purposes. "Agriculture, excluding commercial poultry and swine operations (see section 504.B.16, of this ordinance)." is listed as a permitted principal use under Section 504. A. 8 of the A-R zoning district, Article 5, Upson County Zoning Ordinance. The lots range from .71 acres to 7.3 acres MOL and are further identified as tax parcels 070A 026 through 036 and 044.

Special Exception - The SPX2023-02 applicant and owner is Willie G. Quiller of Upson County. Mr. Quiller has requested that Upson County approve an A-R special exception for a special event facility use at 536 Gordon School Road. The indoor and outdoor special event venue use is listed under the Special Exceptions section of the A-R zoning district, Section 504.B.18, Upson County Zoning Ordinance. The 10.25-acre parcel is more referred to as being in Land Lot 13 of the 16th Land District, tax parcel 046A 017.
